Prerequisite: A minimum cumulative average of 75% and 13.5 university credits including BIOL-ERSC 2260H, BIOL 3391H, and BIOL 3600H. Enrolment is limited and competitive. Students must apply in the academic year before enrolment in the course. Application forms may be obtained from the department website at trentu.ca/biology/experience and must be submitted to the placement officer. BIOL 4400Y may be taken jointly with BIOL 4010Y where the project warrants, but the student may not receive credit for a single-credit thesis in another department or program.

In recognition of my responsibility to successfully complete this field placement, I agree to observe the

following:

- 1. I will report to my placement on time, and will work the hours specified by the host.
- 2. I will adhere to standards of professional conduct required while at my placement, which includes:
 - Professional dress code (no jeans, no yoga/workout clothes, no spaghetti-strap tops, no flip-flops, etc. unless otherwise indicated by the Employer.)
 - NO personal telephone calls UNLESS IT IS AN EMERGENCY
 - NO text messaging
 - NO personal social media additions (from workplace) or updates on company time or on company equipment or online comments about workplace
 - NO personal Internet or email use at host employer
 - Appropriate greeting message on personal telephone (i.e. number given to host employer)
 - Trent University email address only (when required unless company provides you with an email address)
 - Proper etiquette as appropriate for other social media same rules as above
- 3. If I must be absent due to illness/injury, I will telephone (not text message or email) the host employer.
- 4. I will phone within one-half hour BEFORE my normal starting time, and will call in every day, if my necessary absence requires me to be away more than one day.
- If I sustain any injury on the job, I will immediately notify my employer or supervisor and I will contact the Health and Safety Office at 705-748-1460 or by email to humanresources@trentu.ca.
- 6. If I encounter any problems on the job, I will try to resolve them with my immediate supervisor and/or I will contact the Conservation Biology Coordinator at the university.

- 7. I will schedule any personal appointments outside of placement hours. If this is not possible, I will discuss it with the placement host and arrange to make up the lost time.
- 8. I will conform to all of the placement host's policies, procedures, and safety regulations.
- I accept that my placement hours must be worked outside of the normal classroom hours. I cannot miss a class for a placement activity, unless approved by the Conservation Biology Coordinator and class instructor at least 24 hours in advance of the class.
- 10. I accept that my placement is a total of 144 hours, with one supervisor/employer.
- 11. Students are required to find their own placement (with guidance and approval from the Placement Coordinator and the Conservation Biology Coordinator) by September 20. After this date, they will be placed with a host identified by the Placement Coordinator.
- 12. Should students not complete or receive a pass in BIOL 4400Y, they will no longer receive a degree or Specialization in Conservation Biology Science however will receive a Bachelor of Science in Biology degree.
