4. Update on HEPA Filters

Mara let the group know that she had been in contact with facilities and that there is no reason for filters to be unplugged in rooms. Some folks are unplugging them as they feel that they are too loud – they can be plugged in if you see one that's not. If for some reason one is not working, please put a ticket in with IT. Mara inquired about the policy for changing the internal filters, still trying to find out who is responsible for this task.

5. Access to health for Durham Students (Heather)

Heather spoke about barriers of access to health care, particularly for Durham Students and particularly for international students. International students have to pay an upfront cost to access most (if not all) walk-in clinics in the Durham region. Heather is wondering if there might be opportunity for UHIP to partner with a clinic and offer direct billing. Mara to connect Health with contact at UHIP and Durham.
